

The Impact of Divorce

Each year, divorce affects more than 1.5 million children in the United States. Research indicates that the most severe and long-standing negative consequence of divorce for children is the experience of parents' on-going conflict and lack of cooperative parenting.

Meeting in the Middle

Each circuit or county court in Illinois is mandated to have an approved parenting education program consisting of at least four hours, covering the subjects of visitation and custody, and their impact on children.

To meet this mandate, Sinnissippi Centers offers Meeting in the Middle. This four hour group meets the Parenting Education Requirement of Rule 924.

Meeting in the Middle is based on the model program, Children in the Middle. This skills-based divorced parenting program helps children and parents deal more constructively with the impact of divorce.



Cost

The complete four-hour series of Meeting in the Middle is \$50.00.

Course Content

Section 1 (4:00pm - 5:45pm)

The first two hours covers topics such as the range of possible negative effects of divorce on children's adjustment, emotional dynamics of divorce for parents, signs that children may be struggling to adjust, recommendations for effective co-parenting, and improved communication with your child's other parent. Video examples are used for illustration and discussion during sections 1 and 2.

Section 2 (6:00pm - 8:00pm)

The second part of the curriculum covers the impact of chronic stress and conflict on children's emotional, social and physical development, common co-parenting problems, core components of a parenting plan, and age-appropriate visitation considerations. Post separation or divorce issues of self-care, dating, when and how to introduce your child to new partners are also discussed.

As part of Meeting in the Middle program parents will:



- Learn how loyalty conflicts between parents harm their children
- Develop an understanding of the issues of visitation and custody and their impact on children
- Improve direct communication between parents instead of using children as messengers
- Enhance understanding of the effect divorce has on adults and children
- Learn communication and conflict resolution skills to improve co-parenting relationships
- Increase parental support and recognition for children's need to have a relationship with both parents
- Decrease children's exposure to parental conflict

Upon completing Meeting in the Middle, Sinnissippi Centers will provide a letter of completion to the appropriate parties.
