The Sinnissippi Foundation's mission is to provide vital support that can help save lives, increase mental wellness, increase awareness about behavioral healthcare diseases, and reduce the stigma that is a barrier to many who seek treatment.

The Foundation granted a total of 121 CARES and Client Fee Assistance requests in 2017. CARES assists individuals with urgent short-term needs that contribute to their mental wellness. Some examples of how CARES grants help: Preventing eviction, keeping the heat on during the cold winter months, and providing vital medications. Client Fee Assistance grants help individuals afford a small portion of their treatment.
