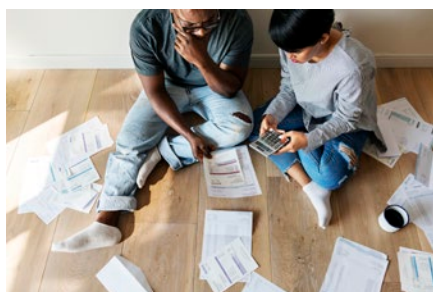


The Sinnissippi Foundation helps to improve the quality of life for individuals and families who are served by Sinnissippi Centers. They may have depression, anxiety, a substance use disorder, or any number of other behavioral healthcare challenges.

The Foundation helps through a variety of programs, but most frequently through three main activities: CARES grants, Client Fee Assistance, and the Holiday Food Basket Project.

Your support of the Sinnissippi Foundation truly makes a difference in the lives of so many each year, people who know someone cares about them because of your generosity. We get the privilege of providing the assistance, but it's all of you who deserve the credit. Thank you!

Approximately 650 individuals were helped in 2018 through the programs of the Sinnissippi Foundation. Each person or family helped has their own story of what that really means, but the impact of even a little help makes a huge difference in the life of someone battling behavioral health symptoms.



The Foundation Granted a total of 89 CARES requests and 30 Client Fee Assistance requests in 2018. CARES requests are most frequently for assistance paying for medications, rent, or utilities during periods that individuals have hit a rough spot in life, and just need a little help to get them back on track. It also improves their mental wellness and quality of life. Who doesn't face added stress during financially rough periods?
