## Providing help offering hope & promoting wellness

### **Supporting Healthy Kids**

The Community That Cares (CTC) Project continues to help kids and

families live healthier, happier lives. CTC's major funding source, a 5-year grant,

ends in December 2015. In 2016, CTC will rely heavily on donations to continue their work. Recognizing the importance of continuing the project, The Sinnissippi Foundation has partnered with the community to raise funds to support CTC. In addition, the Foundation established the Community That Cares Project Fund as an option for donors to designate their support.

#### **CARING More Than Ever**

A record level of requests were received in 2014 by the Foundation to meet the emergency needs of individuals and families. 133 CARES Fund requests were granted, totaling over \$15,500. CARES requests help to provide safe housing or prevent eviction, help individuals obtain vital medications, or keep the heat on during the cold winter months. Since 2008, when requests began to rise rapidly, there has been an increase of over 500% in funds distributed. The Foundation has been able to keep pace with the requests thanks to the generosity of donors and sponsors.

### **Wellness & Recovery**

Nearly 150 individuals attended the annual Wellness and Recovery Celebration held at Sinnissippi Centers' Dixon office. Sponsored by both Sinnissippi Centers and the Sinnissippi Foundation, the annual Wellness and Recovery Celebration is held each September during Recovery Month. Those who are in recovery from a mental illness, a drug or alcohol problem, their family members and other supporters, as well as families seeking wellness all enjoy attending the annual celebration. Speakers tell their unique stories of recovery to encourage others to seek treatment and to continue their recovery.

### Jim Sarver Education Fund

Without an adequate education, individuals do not have all of the tools they need

to achieve a higher quality of life. The Jim Sarver Education Fund, named to honor former Sinnissippi Centers' President/CEO Jim Sarver, has been established to help Sinnissippi clients take the required tests to

receive their GED. The fund will pay for a variety of costs, including test preparation, testing fees, and other costs associated with getting a GED.

### A Great Day of Golf

It was the 10th Anniversary year for both the Foundation's art fund raiser and the gallery. It was a wonderful first ten years together. Expressions offers paintings, photographs, and other genres of art for sale. The pieces are donated by local and regional artists. In addition, there is a wide variety of silent auction items up for bid. The 10th annual Expressions was notable in another way: The event raised more funds than in any other year, nearly \$17,000.

### For Community

"For Community" became the unofficial theme of the Gardenstock Art & Music Festival in 2014. The event is an annual fund raiser for Sinnissippi's Youth Garden Project. Not only does Gardenstock benefit the garden

project, but it has also helped play a role in something of an art and music revival in the area. The 6th Annual

Gardenstock saw over 2,000 art and music lovers attend. World renowned blues guitarist Gerry Joe Weise graced the Gardenstock stage again, along with famed New York Jazz musician Juma Sultan.

### Strong Support

The Sinnissippi Foundation continued to receive strong support during the annual Sinnissippi Employee, Alumni, and Board Campaign. The May-June effort raised the most funds since 2007. In 2014, over two-thirds of employees made a gift or pledge and nearly 130 individuals participated in all. It was in 2008 that a downward economic trend began that affected fund raising for many non-profits. During the same period, the number of individuals and families in need rose. In 2008 requests to the Foundation began to steadily increase. This is a trend which continues to this day.

#### A Wonderful Gift

The Sinnissippi Foundation's Holiday Appeal received a wonderful gift: Donations increased 66% compared to the previous year. The appeal was sent to individuals, organizations, and businesses just prior to Thanksgiving. Historically, donations continue to arrive through early spring. To date, the 2014 Holiday Appeal has raised just over \$8,800.00. Some of the increase can be credited to the newest funds of the Foundation; the Community That Cares Project and the Jim Sarver Eduction Funds.

### **Holiday Food Baskets**

The Foundation's Holiday Food Basket Proiect was one of the biggest in the history of the Foundation. Over two tons of

food was distributed to Sinnissippi Centers' client families in need in Carroll, Lee, Ogle, and Whiteside Counties. In all, 190 baskets

were distributed to families that benefited a total of 674 individuals. Volunteers pack and distribute the baskets just prior to the two major holidays: Thanksgiving and Christmas. The contents of one basket costs an average of \$30. It is often the only holiday meal these families enjoy during the season.

#### Taste of Fiesta

A popular cultural event was revived, in part, due to the support of the Sinnissippi Foundation. The Taste of Fiesta was held on September 6, 2014, in Sterling.

The Foundation provided assistance by servina as a financial agent for donations to the

event's

organizational committee. In future years, organizers will have their own non-profit organization that will receive that support. The Taste of Fiesta provides an opportunity for families to learn about available resources in the community while enjoying rich cultural traditions.
