Remembering a Pioneer

Director

Sinnissippi Centers bid farewell to a friend on February 10, 2017, when **Phil** Jorgensen, Sinnissippi Centers' very first Executive Director, passed away at his home in Dixon. Jorgensen served as

Executive Director from 1966 through 1970 when John Kidwell took over as Executive Director. Jorgensen stayed on at the agency to serve in several roles. He eventually left Sinnissippi in

Jorgensen had attended Sinnissippi Centers' 50th Anniversary Celebration a short four months prior to his death. He penned a letter to the agency offering some of his reflections for

the occasion in which he said, "One of the important issues in the development of Sinnissippi is that mental health services were a larger-city and big-city phenomenon at that time. We were the pioneers in the development of 'rural' mental health services. Sinnissippi was one of the first rural clinics in the state and one of the busiest to this day.


"Without the foresight, dedication, and support of community leaders, interested citizens and health, education, and welfare professionals, Sinnissippi would not have become the very viable agency that it remains to this day. I'm proud to have been the founding Executive Director of Sinnissippi and grateful to our communities and the fine staff in making Sinnissippi a success over these 50 years. You are a blessing!"

Larry Prindaville, former Sinnissippi Centers' Senior Vice President and Chief Administrative Officer, offered his observations about Jorgensen. "Phil was my first supervisor when I started at Sinnissippi in February 1972," says Prindaville. "He was an excellent, experienced social worker, and a very good supervisor. College and graduate school provided the basic credentials for my position as a professional

counselor, but it was Phil's tutelage that developed and nurtured my professional competencies," adds Prindaville.

"Phil consistently espoused the need for, and values of, a spectrum of

locally accessible community mental health services, says Prindaville. "In the early days of the agency there was no state funding of our services, so Phil spent endless hours working with city and county officials to solicit local support and funding. He was highly respected throughout the communities of Carroll, Lee, Ogle, and Whiteside Counties, and was successful in his



local funding for the agency," says Prindaville.

Kevin Buss, a Sinnissippi Adult Services Clinician, echoes much of what Prindaville says. Buss was hired by Jorgensen in 1978 and he was Buss' long time supervisor. Buss says "Sinnissippi was starting its addictions services program, headed by Phil who was Director of Substance Abuse Services at that time. Phil was a driving force in establishing Sinnissippi's addiction services and getting them off the ground," says Buss. In fact, as part of those efforts, Sinnissippi was the first agency in Illinois to provide Intensive Outpatient Group services in a community mental health setting.

"Phil was very sensitive to the community, by example," adds Buss. "He forged a sense of professionalism into the agency that survives to this day.'

"Phil recognized early on the need for integrated treatment of mental illness and substance abuse, that more often than not co-occur, probably about 10 years before the terminology for it existed," adds Buss. "Phil looked at individuals with mental

illness and addiction as the valuable people they were and often said they had 'holes in areas of their lives' that needed filled. He was a visionary and a pioneer

Agencies Join For Better Response

Lee County CPT

You have heard the saying, "one thing leads to another". It's true in Lee County and what it's leading to is a better system for those with a mental illness or substance abuse problem.

Efforts that started several years ago to address the opioid crisis, the Safe Passage Initiative, are now leading to more cooperation locally between agencies to improve the response to those facing a mental health crisis in the community.

Lee County recently launched the new Crisis Prevention Team, or CPT, a collaboration between Sinnissippi Centers, the Dixon Police Department, Lee County Sheriff's Department, the Lee County State's Attorney's Office, KSB Hospital, and the National Alliance on Mental Illness. Individuals who are identified by any of the partners as having a serious mental illness that will greatly impact their functioning in the community will receive coordinated services and response from all the partners. The ultimate goal of the group is to improve the response to individuals and identify them before they reach that crisis stage, keeping them out of the hospital or in some cases, out of jail.

Some of the "red flags" that partners will look for to identify these individuals include those who miss appointments, are not taking their medications, or are showing noticeable signs that their mental wellness is deteriorating. Each person in treatment signs a voluntary medical release with the partners in the team so they can better coordinate care by sharing information.

The team was in the planning stages for about 8 months and officially began the initiative in December 2016. Already individuals have been helped that may not have been helped before, or who may have "slipped through the cracks"

Since its inception, the team has already seen the value to clients and to the community. According to President and CEO of Sinnissippi Centers, Patrick Phelan, "We have been able to work together more effectively to expedite needed services for clients within the community. We have had a few situations where members of the team from several

DBSA Sauk Valley meets on the second Wednesday of the month at CGH Medical Centers' classroom from 6:30 p.m. to 8:00 p.m. Individuals interested in peer support and their family and friends are welcome to attend the meetings. DBSA group meetings focus on mutual aid and strategies for living the fullest life possible. By sharing experiences, insights, and ideas, people get peer-to-peer support from others who have been there. The group offers a safe, supportive, respectful, non-judgmental, and confidential atmosphere.

Services Being Offered At Crest Another exciting and recent development for Sinnissippi is the initiation of on-site counseling services for Crest Foods in Ashton. Crest has a very progressive wellness program, but they wanted to be creative in the way they address emotional well-being for their employees. So, instead of just opting for a traditional Employee Assistance Program, or EAP, Crest decided that having a behavioral health clinician available at the nearby Ashton KSB clinic would truly serve their employees. Sinnissippi Centers' President/ČEO Patrick Phelan says, "I think this becomes a model for other large companies in the area to follow for their own Employee Assistance Programs."

Sinnissippi Takes Third at Stupor Bowl Sinnissippi Centers' took home some hardware from the recent Stupor Bowl held in February at Reagan Middle School in Dixon. With more teams in the event this year than the past three, Sinnissippi was able to take third place at the annual fundraiser for Dixon Schools. of the organizations involved worked together to identify safety plans in order to monitor clients in their home, to make sure they were taking their medications, and to make sure their symptoms were not increasing to the point of crisis.'

All the organizations involved understand the importance of positive relationships with these families and of intervening before a crisis in order to be most

The CPT is a win-win; it costs Lee County no additional dollars. This is an effort of better communication and coordination between partners who have already been serving individuals with a serious mental illness, and this is a better model of care. However, the group does plan to apply for grant funds to help expand these services and outreach in Lee, Ogle, and Whiteside Counties.

The CPT follows the local Safe Passage Initiative. That initiative started in order to address the growing opioid crisis and offered individuals "safe passage" to treatment. Any Lee County resident who enters the police or sheriff's department and asks for help with their addiction to opiates will be placed into appropriate treatment. Individuals doing this can bring their drugs or paraphernalia with them without fear of arrest or charges being filed.

The Safe Passage group began to expand their scope to take into account mental illness since individuals who suffer from addiction often also have a mental illness. and vice versa. The initiative has been so successful that neighboring counties are either adopting it already or considering adopting the idea.

in bringing community behavioral health to this area. He, along with Sinnissippi Psychiatrist, Dr. Wlodzmier Rybak, saw things way ahead of their time," says Buss.

The Community Mental Health Act signed by President John F. Kennedy in 1963 gave the means to achieve an agency like Sinnissippi, but Phil was thinking in this direction long before the legislation took shape according to Buss.

"What I remember at the time when I first met him, he was very bright, very knowledgeable, very committed to the agency, and yet very approachable and friendly. He was very serious and yet very warm at the same time, and he had a great sense of humor. He loved to laugh and tell stories of all kinds," adds Buss.

"Looking back, I think what Phil really reflected was the spirit of the early days of the agency in its generosity, in its humanness. He connected very well to the community and he really built as many bridges as he could in the community to make community mental health a success," says Buss.
"Phil, along with Dr. Rybak, had the vision

and set the stage for what, clinically, became the foundation that Sinnissippi continues to build on in terms of vision and clinical

excellence. Having been here for so many years now I can't imagine us being what we are without that foundation," says Buss.

'Back in the 60's and 70's we were still battling a public perception that wasn't all that warm and inviting to problems in the community existing with either mental health or substance abuse, so Phil really did preach 'the gospel' to the community and to the community leaders and really created an atmosphere of buy-in and acceptance over time that really makes so much possible of what we do today," says Buss.

Buss says that Jorgensen was very good with the community and building alliances, helping the community to first accept and then appreciate what Sinnissippi was doing, and he worked hard to keep those alliances strong.

Jorgensen's commitment to his community remained strong through the rest of his life, he was active in his church, and had owned restaurants in Oregon including the 1890 Club (now LaVigna). He often said, "I have never met a person who has not enriched my life"

In addition to his work at Sinnissippi Centers, Jorgensen was a clinical social worker for Dixon Correctional Center prior to his retirement at age 76 in March 2010. He gave nearly 50 years of his life to mental health.

The kids learn other skills, like communication, leadership, teamwork, and some business skills as it relates to making and selling the T-shirts. It also gives them the satisfaction of helping others - the produce from the garden goes to local food pantries.
