A new system of service provision in Illinois is on the way

Integrated Health Homes

Health Choice Alllinois

On July 20, 2018, the Centers for Medicare & Medicaid Services approved an Illinois Medicaid state plan amendment that allows Illinois to launch new integrated health home services statewide for Medicaid recipients.

Health homes in Illinois are designed to serve the needs of individuals with physical and behavioral health conditions who have Medicaid and meet other specified criteria.

A health home is not a physical place actually, but is a service provider or group of

service providers who ensure that all of an individual's healthcare needs are met. The health home will not provide all of those services directly, but instead provide linkage to a variety of community service providers who will help the individual to meet their particular needs.

An Integrated Health Home (IHH) is a new, fully-integrated form of care coordination for the majority of Illinois Medicaid recipients. Many Medicaid recipients will be linked to an Integrated Health Home provider based on their level of need and the provider's ability to meet those needs.

The Integrated Health Home will be responsible for care coordination for members across their physical, behavioral, and social care needs. Care coordination involves a thorough assessment of needs and strengths in every aspect of the individual's life. A care plan is then developed to prioritize what needs should be addressed, by whom, and through what interventions. Then formal linkages are made to those service providers who can best meet those needs. Finally, care coordination involves consistent follow-up and monitoring of health outcomes and addressing any risk factors that arise over time

Integrated Health Homes will work with the existing selection of Managed Care Organizations (MCOs) to provide their services. Managed Care is a health care delivery system organized to manage cost, utilization, and quality. Medicaid managed care provides for the delivery of Medicaid health benefits and additional services through contracted arrangements between state Medicaid agencies and MCOs that

accept a set per member per month (capitation) payment for these services.

Originally scheduled to launch on October 1, 2018, implementation of Integrated Health Homes has been delayed several times and at the moment of this writing, the best estimate available from the state for an implementation date is some time in February or March of 2019. and preparation has continued, so the information we have passed along in this article is subject to change, but is accurate at this writing.

Medicaid recipients who are going to be served by an Integrated Health Home organization will likely receive a communication from the State of Illinois about what Integrated Health Homes are. In the next few months, recipients will receive a letter from their MCO with the choice of IHH's available in their geographic area. They may either choose an IHH or one will be assigned for them approximately one month later. Medicaid recipients may also choose to opt out of Integrated Health Homes altogether.

Sinnissippi Centers will be a subcontracted provider for two Integrated Health Home provider organizations. We will provide current and former service recipients information about which health homes the organization will provide care coordination services for, so that they can receive their care coordination from Sinnissippi if they choose to do so.

Individuals who choose Sinnissippi Centers (SCI) as their IHH care coordination provider will often have a history of behavioral health needs. However, individuals who primarily struggle with physical health challenges may also be attributed to SCI through the larger IHH's. The care coordination provided by organizations like SCI is equally effective in addressing behavioral and physical health needs.

We are looking forward to providing enhanced services to current clients and serving many individuals who we have not previously served.

New Community Support Team

Starting in the new year, Sinnissippi Centers has added Community Support Team (CST) services to our offerings. CST services are intensive and provided to those individuals experiencing the most significant mental illnesses. CST staff will be seeing those clients who have a history of chronic psychiatric problems, involving multiple hospitalizations, suicide attempts, and those who make frequent use of crisis services.



Case loads are generally small and the team works closely together to address the needs of each client. Many of the services are provided in the community.

Members of the team see clients two to three times a week, often in their homes, providing support to help manage their mental health symptoms. By seeing clients in their home the team can better assess their level of functioning and better understand the areas that they need help with on a daily basis.

CST utilizes a Licensed Clinical Social Worker (LCSW), as well as Recovery Support Specialists. Recovery Support Specialists are responsible for assisting and ensuring the well-being of the clients maintaining a positive, therapeutic, and safe environment. They link clients with community resources in an attempt to help them engage in recovery services such as AA support group meetings, employment services, primary health care, and other resources. Recovery Support Specialists provide peer-to-peer recovery support services to clients, their families, and other allies at every stage of recovery.

The goal of the CST is to increase clients' stability in the community, reduce their number of crises, reduce psychiatric hospitalizations, and reduce the number of problems with law enforcement.

Results of this approach at other mental health agencies show this program to be a great success.

Speaking out and being the best advocate for your healthcare

Advocating for Yourself

Note: This article was written by a consumer who wanted to share their experience in order to help others advocate for themselves and achieve their best possible level of mental wellness. At the same time it helps those that don't have a mental illness better understand what someone who does can go through on a daily basis.

The fundamental principles of recovery are: Education, personal responsibility, support, spirituality, hope, and self-advocacy. What I have learned in counseling, classes and conferences at Sinnissippi Centers has helped me be more assertive and advocate for my needs.

Self-advocacy can be defined as being able to express oneself clearly and calmly in order to get ones needs met. Another way I look at it is that it is just "going for it" with courage, persistence and determination.

Over the past 35 years, since being diagnosed with diabetes and bipolar disorder, I have found out how important it is to use self-advocacy to help aid in my recovery.

I have been involved in leadership roles as a secretary and president in a consumer-run support group. This support group meets monthly at Sinnissippi Centers. The group has written letters to legislators in Springfield about getting mental health bills passed. I have also been involved in several rallies that were also held in Springfield. As a group we are aware of being firm and persistent. This helps us achieve our goals or at least gets us closer to the goal that we would like to achieve. Our voices are stronger and more effective when we join together. We know we have rights, power, and worth.

While attending NAMI (National Alliance for the Mentally III) meetings I received education about recovery and have met some new people with similar issues. I was also given the opportunity to share my recovery stories. This was helpful for me to feel like I can possibly

help others and this also helped me with my self-esteem.

There have been several times when I have used "self-advocacy" to help myself in some medical situations. I had found by just asking for help to the right people consistently has helped me get some needed medications paid for that may not have been.

For example one of my most recent

successes with selfadvocacy has been with my pharmacy in regards to a large co-pay pertaining to my diabetic medications. I felt very overwhelmed and talked with my social worker at Sinnissippi Centers. I then went to the Medicaid office to inquire about getting a card to cover those months that needed to be covered and I also called the pharmacy's corporate office several times to check on what my Medicare plan had paid.

I was not getting the results that I needed so I called the aging and disabled research center at the Whiteside County Senior Center in Sterling, Illinois. The staff were extremely knowledgeable, caring, assertive, and most importantly dedicated to helping me solve the situation I had. I also had the support of my family and friends as they were willing to listen and give me encouragement. After making many visits to these places following good advice and refusing to take 'no' for an answer I got the results that I wanted. I then made a call to my pharmacy's corporate office and spoke with the person in charge of the bills who told me to disregard that account. After hearing this I felt relieved, happy, successful, and hopeful.

It would have been very easy for me to just give up after hitting all those walls but I chose to believe that there was a solution to my problem. Hope is the core of my recovery and it keeps me going. Recovery happens when you take control of your life and your goal is to get better
